Sub: Recognition Certificate for the School under sub-rule (4) of rule 11 of Right of Children to Free and Compulsory Education Rules, 2011 for the purpose of Section 18 of Right of Children to Free and Compulsory Education Act, 2009

Sir,

With reference to your application dated, 13/06/2025 and subsequent correspondence with the school/inspection in this regard, I convey the grant for provisional recognition to the International Academy of Scholars, Kharija Dolaigaon Part-1, Kishan Bazaar, Bongaigaon for Class Pre-primary to Class VIII for a period of 3 (three) years w.e.f 20/08/2025 to 21/08/2028.

The above sanction is subject to fulfillment of following conditions:

- (1) The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
- (2) The School shall abide by the provision of Right to Children to Free and compulsory Education Art, 2009 (Annexure – I) and the right to Children to free and compulsory Education Rules, 2011 (Annexure – II)
- (3) The Schools shall admit in Class 1, to the extent of 25% of the strength of the Class, Children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion. Provided further that in case of pre-primary classes also, these norms shall be followed.
- (4) For the children referred to in paragraph 3, the school shall be reimbursed as per section 12(2) of the Act. To receive such reimbursements school shall provide separate bank account.
- (5) The society/school shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
- (6) The school shall not deny admission to any child
 - a) For lack of age proof
 - b) if such admission is sought subsequent to the extended period prescribed for admission,
 - c) On the ground of religion, caste of race, place of birth of any of them.

(7) The school shall ensure

- (i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
- (ii) No child shall be subjected to physical punishment or mental harassment.
- (iii) No child is required to pass any board examination till the completion of elementary education.
- (iv) Every child completing elementary education shall be awarded a certificate as laid down under rule 19.
- (v) Inclusion of student with disabilities/special needs as per provision of the Act.
- (vi) The teachers are recruited with minimum qualifications as laid under section 23(1) of the Act. Provided that the current teachers who, at the commencement of this Act do not possess minimum qualification shall acquire such minimum qualifications within a period of 5 years from the commencement of the Act
- (vii) The teacher performs duties specified under section 24(1) of the Act.
- (viii) The teachers shall not engage himself or herself for private teaching activities.
- (ix) Fire security arrangements as per norms specified under the National Building Code of India Part 4 are set up.
- (x) Fee to be charged from the children is notified every year in such manner as directed by Commissioner, Rajya Shiksha Kendra before the commencement of academic session & District Education Officer is intimated before the beginning of academic session.

(8) The school shall follow the curriculum laid down by appropriate authority.


(9) The school shall enroll student proportionate to the facilities available in the school as prescribed in section 19 of the Act. (10) The school shall maintain the standards and norms of the reported at the time of last inspection areas given under:

(11) No unrecognized classes shall run within the premises of the school or outside in the same name of School.

- (12) The School buildings or other structures or the grounds are used only for the purposes of education and skill development.
- (13) The school is run by a Society registered under the Societies Registration Act, 1860 (21 of 1850), or a public trust constituted under any law for the time being in force.
- (14) The accounts should be audited and certified by a Chartered Accountant and proper accounts statement should be prepared as per rules. A copy each of the Statement of accounts should be sent to the DE EO every year.
- (15) The recognition Code Number allotted to your school is No. Genl-70/ Non-Govt/ 2025/2337 Dated : 20-08-2025. This may please be noted and quoted for any correspondence with this Office.
- (16) The school furnished such reports and information as may be required by the Director of Education/ Dist. Education Officer from time to time and complies with such instructions of the State Govt. /Local Authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies if working of the school.
- (17) Renewal of Registration of Society if any, be ensured.
- (18) Other conditions as per Annexure "III" enclosed.
- (19) The School shall always be run as a private institution and will not claim for any grants-in-aid or seek Provincialisation by the government in future.
